# **Chairman's Report**

Firstly, the community council members would like to thank Hong Zhang (Angus Council) and Councillor Whiteside, Councillor Melville and Councillor Dorran for the support that has been offered throughout the last year. In addition to that we would also like to thank Constables Brennan and Irvine and Sergeant Grieve from the Community Policing team for their continued support and engagement.

Since last September the area has faced challenges from the weather when we witnessed multiple areas being affected by flooding. Members of the community council have been working throughout the year to create a resilience plan, which successfully attained some funding. This work will take time to fully form, however, the work that has already been done has been of benefit.

There have been the usual standing items and issues discussed throughout the year, including the speed of traffic throughout the villages. Our 'silent' member 'pop-up Jim' has been getting put to work around the area and it does appear that when he is at work there is an impact to the speed of traffic. We will continue to put them to use around the area and liaise with Community Police to maximise their impact.

Looking toward next year work will continue for the community communication and resilience plans. Community council members are now entering our third year, and I am sure we would all agree that we are still learning. Community engagement is not something that happens easily overnight and it appears that, unfortunately, residents tend to get more evolved when something is wrong. The work in the background to build the communication and resilience plans will hopefully go a long way into starting positive, forward-thinking conversations, instead of reacting to flash-points.

Finally the community council would like to thank the members of the public who have attended meetings and contributed to discussions.

## **Planning Report**

Since the last AGM, the Community Council has considered 22 planning applications, of which 2 were withdrawn and one of which was recent to the September meeting. There were a range of application types including citing a caravan temporarily for residential use, several enquiries and full permission applications about new build houses (single / small development), two relating to farm development requests. The rest were minor domestic extensions. None of the applications garnered a particularly strong feeling from the residents in any sufficient numbers or were controversial enough to warrant a strong objection or support. None posed a significant issue with any local plans or concerns from residents (e.g. school places etc). Where there were direct neighbour concerns raised advice was given on how to make appropriate representations on through the Planning Portal or aspects of the permissions being requested were explained.

There were two additional applications brought to our attention that are NOT in our area but are in close proximity to our designated zone. These included the creation of a battery storage system on land at Templeton, and the creation of a new football / event stadium, housing, crematorium, hotel, restaurants, extension to ice arena and new road configuration in Dundee on land near Camperdown. For those latter two we are unable to make any official representation as a community council but shared details with our area via Facebook and noted these at our meetings as well.

As a community council we have reached out to Angus Council and expressed our interest in helping to contribute towards our local area development plan as they shape their regional response to the National Planning Framework 4. We await further invitations and engagement on this matter.

### **Treasurer Report**

The current financial health of the council is very good. This is due to the healthy state the current council inherited.

We did not manage to change from our current email hosting as we intended and therefore we underspent our operating grant from Angus council as our only recurring expenses are £15 for the website and email hosting, and the bi-monthly room hire charge.

During the year our other outgoings were the completion of the participatory budgeting grant transfer to Muirhead church; paying for pop-up policeman Jim and the Christmas tree donations to schools and nurseries within our area that wanted to receive them.

We ended the year with almost £3k in our account. That includes £500 set aside to match The NCR resilience funding.

This planning application was approved and news of this was conveyed in the Courier on the 12th of March 2024. It was brought to the attention of the Muirhead, Birkhill, and Liff Community Council on the 15th of March 2024. The community council members were surprised at this because we were unaware of the planning application despite receiving the weekly planning lists. When we receive these we search through for the ones that are noted as assigned to our Community Council in the information. We did not find this application.

We were aware of this development as the applicants came to one of our meetings to discuss this with us in 2023, and they spoke to us as part of their initial consultation prior to making a full application. We had members of the public in attendance as well at the time, and there were concerns raised at that point about the access routes and impact of traffic on Gourdie Brae and towards Liff.

We were unsure how we could have missed the full application being submitted as we would have wished to comment on any proposals that could cause implications for traffic access and egress and general road safety, and we would have reflected the concerns raised in the consultation had there been no changes to the initial proposals that were presented. Upon further inspection, we can see that the application was wrongly assigned to Monifieth Community Council. As a result, we did not find the application in our weekly searches.

We were very concerned that due legal process has not been followed; the application was not validated correctly with the basic details, and as a statutory consultee we were not afforded the opportunity to comment on this application due to, we assume, an administration error on behalf of Angus Council. The application being wrongly assigned to Monifieth made it unsearchable for us or anyone living in our area who may have had an interest in commenting.

In light of this, we have written to the Council and asked how this could have happened and why no one in the planning committee checked that it had been correctly assigned, and whether there is any recourse that would allow the population of the Muirhead, Birkhill, and Liff Community Council to review a major proposal that significantly affects

		them. The initial response that we received was unacceptable as this basically blamed the Community Council for not checking the addressing on the several pages of documents that are issued on the list each week. We wholly rejected this position and submitted a formal complaint detailing our concerns and asking for information on how this could have happened and be prevented int the future again. Cllr Whiteside and Cllr Melville also raised their concerns that this had happened. As a member of the Planning Committee they had read the associated reports during the meeting and assumed that our lack of response meant no concerns had been raised.  We await a formal response to our complaint. In the meantime, a statement has been posted on the Facebook pages.

	application for Electricity Pylons replacement programme	17/07/2024	Residents may be aware that SSE are proposing to upgrade the electricity supply between Aberdeen and Westfield. The bit that would affect our area the most is from Tealing to Westfield. SSE have applied to the Scottish Ministers to carry out the project, and the Scottish Ministers have said they have to do a consultation first. This has been on going for some time now. They are currently seeking to conclude their Stage 2 of the project by the 18th of July. This means that under Stage 1 they looked at all the potential options and narrowed these down into Stage 2. Throughout this period they have to speak to the communities that are affected by the remaining options and solutions.
			The justification for this project is that it's necessary to support Scotland's transition towards a Net Zero future and the requirements of the interim targets by 2030. This is a really big part of the government's strategy as Net Zero can't be achieved unless there is more electricity capacity across the grid, and that electricity needs to come from renewable sources in the first place (hence the northern starting point in Aberdeen). To get more capacity, they need to beef up the transmissions lines across the country so that they can deliver more electricity as we reduce, and eventually eliminate, our reliance on gas. When we put new renewable sources of energy in our houses they require a bit of power to keep

them going, and as we switch to buy electric cars in favour of

diesel or gas, we increase the amount of electricity that we demand to make it all work. Overall it needs more power to be available.

This particular project appears to have several elements to it including a new 400kV substation in the vicinity of the existing Tealing Substation (the new stations is now known as the Emmock 400kV Substation project), and then the upgrade to the existing overheard lines that run from Tealing and will pass through our area towards Westfield.

The upgrading of the substation is significant and will be a very large development in Tealing. The overhead lines routes are still to be determined in detail as there are several options, but they too will be significant and will run through part of our areas. Of concern of several residents in our area and beyond is the height of the pylons. To carry the larger capacity SSE advise in their FAQs the pylons will range between 42m to 65m. The information on-line is a bit confusing and it's unclear quite what is going where. It is worth noting that in both cases there are alternatives ie an enclosed substation which is smaller and looks a bit like a giant warehouse, and underground cables. However, these options are far more expensive to do and, in some cases, it can mean long power outages if anything goes wrong because they are more difficult to identify, access, and fix. They are clear in their FAQs that the costs of this project will ultimately be passed to all consumers in Scotland and they advise that underground cables are 5-10 times more expensive than over ground cables.

The current proposed route would come into the north east of Dronley Wood, diagonally through the woods towards the South West until just before Piperdam where it would shift south. This is a long our existing 275kV line that we already have. It is not clear how they are proposing to route the cable for our section and whether we would see bigger pylons or underground cables etc. We have emailed them to ask for clarification

The Community Council are, as normal, able to help represent the feelings of the community but would always continue to encourage individuals to put forwards their opinions as well. The current consultation is open until the 18th of July 2024. After this, they will seek to collect and reflect on the comments before submitting more detailed planning applications. There will be further opportunities to comment at that point too, although the options will be firmed up significantly by then.
